NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA

Proposed Work:

REAR GARDEN: 1 x Horse Chestnut (T1) - Reduce crown height back to previous, most recent reduction points (approx. 1.5m - 2m). Reduce lateral and sub-lateral growth in the lower crown back to previous, most recent reduction points (approx. 1.5m), whilst preserving a suitable amount of furnishing growth in order to preserve crown continuity. Thin crown density by 20%.

1 x Horse Chestnut (T2) - Reduce height back to previous reduction points (up to 1.5m). Reduce lateral and sub-lateral growth by approx. 1m - 1.5m. Thin crown density by 20%.

1 x Horse Chestnut (T3) - Reduce height back to previous reduction points (up to 1.5m). Reduce lateral and sub-lateral growth by approx. 1m - 1.5m. Thin crown density by 20%. Remove one low lateral limb (already truncated).

1 x Lime (T4) - Thin crown density by approx. 20%.

1 x Mature Bay (T5) - Reduce crown by approximately 20 - 25% (1.5m - 2.5m).

1 x Thorn - (T6) - Thin crown density by 15 - 20%. Raise overhanging branches over neighbouring garden by approx. 1m.

The Council has considered your notification of intended works to trees dated 08 March 2021 and does not wish to object.

Informative(s):

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
