NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA

Proposed Work:

REAR GARDEN: 2 x Holm Oak (Evergreen) (Quercus Ilex) (T3 & T4) - Reduce height back to previous reduction points approx. 4m - 5m. Reduce over garden side only back to previous reduction points 2m - 3m.

1 x Bay (Laurus Nobilis) (T5) - Reduce in height by approx. 6m to suitable growth points, trim all round to shape and contain.

1 x Yew Common (Taxus Baccata) (T6) - Reduce back towards path by approx. 2m to suitable growth points.

1 x Holm Oak (Evergreen) (Quercus ilex) (T7) - Remove limb growing into Chestnut Tree.

1 x Silver Birch (Betula Pendula / Alba) (T8) - Fell to ground level.

1 x Viburnum (T9) - Fell to ground level.

1 x Dead Tree (T10) - Fell to ground level by sectional take down

1 x Stump (S10) - Grind down stump to approx. 300mm below ground level.

1 x Cypress (T11) - Remove pegs.

1 x Holm Oak (Evergreen) (Quercus ilex) (T12) - Reduce in height by approx. 4m, trim to contain and shape.

1 x Yew Common (Taxus Baccata) (T13) - Reduce back from Apple tree by approx. 1m.

1 x Laurel (Prunus spp) (T14) - Reduce to a height of approx. 1.5m, reduce back from Apple tree by approx. 1m. to contain and recreate hedge form.

The Council has considered your notification of intended works to trees dated 10 March 2021 and does not wish to object.

Informative(s):

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
