Proposal:

Installation of two mechanical ventilation units at basement and ground floor to the rear of the property for noise mitigation during construction of the HS2 railway at Euston.

- 1 The works hereby permitted shall be begun not later than the end of three

years from the date of this consent.

Reason: In order to comply with the provisions of Section 18 of the Planning (Listed Buildings and Conservation Areas) Act 1990.

- 2 The development hereby permitted shall be carried out in accordance with the following approved plans:

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy D2 of the Camden Local Plan 2017.

- 3 All new work and work of making good shall be carried out to match the existing adjacent work as closely as possible in materials and detailed execution.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy D2 of the Camden Local Plan 2017.

- 4 The mechanical ventilation units and external vents hereby approved are for a temporary period only and shall be removed from the property, and the affected historic fabric reinstated to its pre-installation condition and made good using sensitive repair techniques using materials and techniques to match the existing building, within 6 months of the HS2 noisy works period ending, for which they are required.

Reason: The type of works are not such as the local planning authority is prepared to approve, other than in exceptional circumstances and for the limited period required, in view of their appearance and their impact on the special interest of the listed building. The permanent retention of the works would be contrary to the requirements of policy D1 and D2 of the London Borough of Camden Local Plan 2017.

- 5 The external metal vents serving the mechanical ventilation units shall be coloured to match as closely as possible the adjoining external wall finish.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy D2 of the Camden Local Plan 2017.

6 Reasons for granting listed building consent.

This application seeks consent for the installation two mechanical ventilations units to the basement and ground floor as part of the noise mitigation works during construction of the HS2 railway. Previously consent has been granted to install secondary glazing in the property so the mechanical ventilation will allow background ventilation to the properties without the need to open any windows.

The application site is a grade II listed mid-terrace townhouse located in Camden Town Conservation Area. It dates from 1821-32 and is part of a symmetrical four storey terrace of twelve houses. The rear of the properties are constructed from stock brick with the third floor being a slate clad mansard roof.

The proposed measures are intended to meet the functional requirements of reducing noise within the residential property and meeting the environmental requirements specific to the circumstances of this application, whilst minimising the impact on the significance of the heritage asset and minimising inconvenience to the residents.

The proposed input ventilation is by means of the installation of a mechanical input fan units specified as the Sonair F+ device (manufactured by Titan or similar). The units will be electrically-powered with push button controls to control the volume of air within the room interior, with ventilation rates adjustable from 28-225 cubic metres/hour.

The units will vent out through the rear façade by means of circular grille which projects out slightly from the brickwork. The external vents can be coloured to help them blend in with the surrounding brickwork or render. Both units will not be visible from the surrounding area so will only cause a limited amount of harm the special interest of the listed building and therefore a condition of this consent requires that, on completion of the HS2 construction works, the mechanical will be removed from the property, and the affected historic fabric reinstated to its pre-installation condition and made good using sensitive repair techniques. All the components of the ventilation unit, both internal and external, will be removed, the opening will be and brick put back to match the existing, internal plaster finishes will be reinstated and made good, using materials and techniques to match the existing.

The proposed mechanical ventilation will cause less than substantial harm (para 196 of the NPPF) to the special interest of the listed building. This level of harm has been reduced to the minimum possible and the works will be removed when no longer required. Great weight is given the special interest of the listed building but this is balanced with the public benefit of keeping the building occupied and in residential use (its optimal viable use) during lengthy HS2 construction works. In this case the public benefits of the scheme outweigh the limited amount of reversible harm which is proposed and therefore it is recommended that the application is approved.

Public consultation was undertaken for this application. Camden Town CAAC was also notified of the application and responded with no objection to the

proposal.

Special regard has been attached to the desirability of preserving the listed building and its features of special architectural or historic interest, under s.16 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

As such, the proposal is in general accordance with policies D1 and D2 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2021 and the National Planning Policy Framework 2019.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraph 38 of the National Planning Policy Framework 2019.
