## DECISION

## **Listed Building Consent Granted**

Address: Long Stables The Stables Market Chalk Farm Road London NW1 8AH

Proposal:

Refurbishment and reconfiguration of existing toilets and associated internal alterations at first floor level.

Drawing Nos: 210401 Cover Letter, Design & Access Statement, Plans & Elevations.

The Council has considered your application and decided to grant Listed Building Consent subject to the following condition(s):

Conditions And Reasons:

1 The works hereby permitted shall be begun not later than the end of three years from the date of this consent.

Reason: In order to comply with the provisions of Section 18 of the Planning (Listed Buildings and Conservation Areas) Act 1990.

2 The development hereby permitted shall be carried out in accordance with the following approved plans: 210401 Cover Letter, Design & Access Statement, Plans & Elevations.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy D2 of the Camden Local Plan 2017.

3 All new work and work of making good shall be carried out to match the existing adjacent work as closely as possible in materials and detailed execution.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy D2 of the Camden Local Plan 2017.

## Informative(s):

1 The proposals affect the Long Stable building which forms part of a group of grade II listed buildings within the Camden Goods yard complex. The ground floor of the building was constructed in 1853-55, with the first floor added some 30 years later. The building is constructed from yellow stock bricks, the roof is slate. The building houses a restaurant at ground and part of the first floor. There is also a public washroom at first floor level which is the subject of the application.

The public washroom is accessed via an external metal staircase that leads to a lobby. Leading from the lobby are two doorways that lead to male and female washrooms. The two washrooms are split by a partition that creates two small, linear spaces.

The proposals are to remove the partition to create one, large, unisex washroom. The washroom is redecorated as part of the proposals. The flooring within the washroom is replaced with marble tiles and within the lobby, black concrete tiles. The plaster and tiles within the washroom are removed and the historic brickwork revealed. The cubicles and wash basins are stainless steel.

The partition is a modern addition to the building and has no historic value, its removal is therefore acceptable. The existing pipes and services are reused within the scheme resulting in no additional intervention into the building. All fixtures and fittings are fixed into the mortar joints avoiding harm to the bricks. The sinks are fixed to an area that has been boxed out to conceal pipework. In addition, the flooring is slightly raised to protect the flooring underneath.

The proposed works will not harm the special interest of the grade-II-listed building.

The site's planning history has been taken into account in making this decision.

Special attention has been paid to the desirability of preserving the special interest of the listed building, under s.16 of the Listed Buildings and Conservation Areas Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013

As such, the proposal is in general accordance with policy D2 of the Camden

Local Plan 2017. The proposed development also accords with the London Plan 2021 and the NPPF.

- 2 Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts that cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. - 3 You are advised that any works of alterations or upgrading not included on the approved drawings which are required to satisfy Building Regulations or Fire Certification may require a further application for listed building consent.

You must secure the approval of the Council's Noise and Licensing Enforcement Team prior to undertaking such activities outside these hours.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraph 38 of the National Planning Policy Framework 2019.
