Mature tree covered by a TPO. Large limbs overhanging rear garden of 20 Asmara. Deadwood throughout canopy. Tree appears to be in decline with overlong scaffold limbs. To consolidate energy levels and contain form to lessen likelihood of branch or limb failure:
Reduce canopy all round by approximately 25%. (4m in height and 4m in lateral spread) Prune to growth points and maintain a natural flowing form where possible. Remove deadwood weak or suppressed branches. Remove ivy from stems.
