T1Bay x 1(Laurus nobilis) Hedge. Suggested works:

- Reduce large peg above hedge below hedge line

Rear garden

T2Sycamore x 2 (Acer pseudoplatanus) These trees are encroaching on neighbours property.

Suggested works:

- Lift over neighbours by removing lowest 3 branches back to the main stem
- Reduce back from neighbouring propertyby approx. 2m to suitable growth points
