Hi Scott,

Thanks for your email. I've spoken again to the Tree Officer and he's happy with the removal of the phormiums as they are of low biodiversity value; and he's suggested that Sorbus aucuparia "Cardinal Royal" would be suitable, provided they are single-stemmed specimens as opposed to of a multi-stemmed, shrub-like form. He's also noted that your email reads as if you are only proposing 1 tree, which is not sufficient to satisfy the condition. There appears to be space along the front garden boundary with No. 26 for at least 2x trees and 1x on the opposite boundary with No. 30.

Please could you revise the plans in line with these comments.

Dear Kate,

Nice to hear from you, many thanks for your email regarding the front landscaping proposal for 28 Harley Road.

I have asked Maydencroft who developed the landscape proposed to clarify the matter further regarding the selections made.

*The Magnolia 'Susan' has an ultimate height between 2.5 to 4 metres with a spread of the same dimensions, this would be quite a reasonable sized tree given the size of the shrub beds, the relationship of the proposed tree to the existing retained trees (i.e., Horse chestnut and Boxelder maple) and to scale of the front garden. The 4 No. Mahonia x Media 'Winter Sun' would have an ultimate height between 2-5 to 4 metres and a spread of 1.5 to 2.5 metres. The*

*Mahonia can be managed to appear as either large shrubs or have a tree-like form. The 2 No. Phormium 'Maori Queen' would have an ultimate height and spread between 1 and 1.5 metres.*

*A number of the shrubs can also be managed / grown considerably larger for example [but not limited to]: Aucuba japonica 'Crotonifolia', Leycesteria formosa 'Purple Rain', Viburnum tinus 'Gwenllian' and Weigela 'Florida Variegata' all have an ultimate height and spread between 1.5 to 2.5 metres, the Ligustrum ovalifolium 'Aureum' also has an ultimate height and spread between 2.5 to 4 metres.*

Given the above information, please can you advise if trees are required.

If trees are required: *they would recommend the removal of both of the "phormiums" to be swapped out for one of the following: Acer palmatum 'Butterfly' or Sorbus aucuparia 'Cardinal Royal'.*

I would be grateful, if you could advise which option is preferred and we will make the amendments accordingly.

Good Afternoon,

Further to my earlier email, I've now discussed the application with the Council's Tree Officer. He notes that, whilst you have proposed a broad range of plants, you have not proposed any trees. There is one Magnolia which could form a tree in the long term but it is more of a shrub. Paragraph 11 of the appeal decision notes that the Arboricultural Report suggests ornamental planting close to the boundary with No. 26 and to the central area of the site "*which should look to incorporate smaller trees and/or larger shrubs*". The wording of the condition then specifically refers to tree planting and soft landscaping works and it refers to trees, plural.

As such, please could you revise the details to include some trees too.
