Proposal:

Installation of water tank comprised of galvanized steel tank and frame within car park to rear of hotel.

Drawing Nos: 06-A, 02-A and 01-A.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 The development hereby permitted shall be carried out in accordance with the following approved plans: 06-A, 02-A and 01-A.

Reason: For the avoidance of doubt and in the interest of proper planning.

Informative(s):

1 Reasons for granting permission.

The proposed water tank would appear as an unobtrusive and utilitarian feature within the car-park to the rear of the site. The tank would be of galvanised steel in off-white, while the frame would be galvanised steel. The water tank would rise 3.5m over the boundary wall however would not appear unduly prominent from the neighbouring housing estate. The water tank would not be readily visible from Fellows Road on account mature trees and vegetation surrounding he entrance to the car park. The water tank would not harm the character of the Britannia Hotel, wider area or setting of nearby conservation areas. The tank would not face directly towards residential windows of the nearby housing blocks and therefore would only be visible in glimpse views from surrounding residential properties.

The water tank would not have an adverse impact on residential amenity.

No objections have been received prior to making this decision. The planning history of the site has been taken into account when coming to this decision.

As such, the proposed development is in general accordance with policies A1 and D1 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2021 and the National Planning Policy Framework 2019.

Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974.
