Prune T1 Horse Chestnut located at the back of property left side according to the following specifications:

- Clean to remove all dead, diseased and broken branches 2 centimetres in diameter and larger throughout crown to improve health and appearance and reduce risk of branch failure.
- Thin crown to remove approximately 10% of live branches to improve light and air penetration through crown. Most thinning cuts will be between 1 and 2 centimetres in diameter.
- Reduce crown height and spread by approximately 3-4 metres to enhance natural form.
