G1 – Group of 4X Acacia –

Tree shrouded of Ivy and showing large volumes of deadwood, some of the trees maybe completely dead. We advise:

- Cut and kill ivy removing 1 meter of all growth from ground level.
- Shave remaining parts of crown removing all small growth from the Ivy.
- Remove deadwood & dying branches from the group of trees.

T2 – Mature Sycamore –

Suspect fault noted at 2 meters with included bark & signs of movement. We advise:

- Remove all deadwood from crown reduce canopy by 3-4meters reshape & tidy.
