Rear Garden
T1 Lombardy Poplar x (Populus nigra 'Italica') Reduce Extra Large (20-22m high tree) Lombardi Poplar by approximately 1/3rd (Equating to approximately 6-8m in height), re-shaping the vertical growth to balance-in with the side laterals. Leaving a natural looking shaped crown, with reduced windthrow. We may have to prune slightly below the previous reduction points dependent on the level of decay within these old points.
Rear Garden
T2 Silver Birch x 1 (Betula pendula / alba) Reduce side lateral overhang from garden by 1.5-2m
