e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Fir Tree (T1) - Fell because of excessive shading to properties in the vicinity of the tree (45A, 45B, 47A, 47B) in winter months. This is because the leaves do not shed all year. There is another tree (Rowan Tree) in extreme proximity to T1. The Rowan tree sheds its leaves and doesn't cast a large amount of shade so no work is needed on this tree. The roots of T1 are damaging to the boundary wall of number 45 and 47. Severe pigeon droppings from the T1 make the bins and shed in the front garden untouchable and the ground extremely dirty. The roots have caused the stones in the front garden to become uneven and damaged. The neighbours have expressed their wish that they would like the tree to be felled.

The plan is to fell the tree down to the base. Replanting another tree in the same location will not be viable as a growing tree will do more damage to the boundary of the front gardens.
