We previously notified you of intent to remove and we were allowed to do so. Application Ref: 2015/5553/T (James Remington).

In 2017 the tree was cut down to a stump and the tree surgeon told us he had injected stump killer. However it did not die but regrew from the stump and at the base.

I am applying again to notify you that I wish to fell this regrowth.

It now greatly obstructs the pavement and pedestrians, as it is on the pavement boundary. Also it greatly overhangs the neighbours' front garden at No 3 Rochester Terrace, NW1 9JN.

5. Identification of Tree(s) and Description of Works

As stated in our prior notice, we would like to plant a less vigorous tree in the front garden to replace it. I have a plum tree ready to plant, on the sunnier side of the front garden in a spot further from the pavement so that even when it is fully grown it will not obstruct the pavement and pedestrians.
