1 Reasons for approval:

Condition 3 requires submission and approval of a written confirmation of a suitably qualified chartered engineer to oversee the proposed basement excavation works during construction. The Applicant has submitted a letter

from Smithers Purlow (03/02/2021) confirming their appointment as Chartered Structural Engineer for the project. The engineers are members of the Institution of Structural Engineers, the Institute of Civil engineers and the Chartered Association of Building Engineers (CABE) (Confirmed engineers posess BEng (Hons) MSc GMICE and BEng(Hons) CEng MIStructE) which are considered acceptable and complies with the Council's supplementary planning guidance document 'Basements'. Condition 3 of 2020/3953/P can therefore be discharged.

Details of hard and soft landscaping have been submitted to discharge condition 6 including garden plans and planting proposals. The Council's Tree and Landscape Officer has raised no objection to the proposals. Condition 6 of 2020/3953/P can therefore be discharged.
