e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Pine x 4 (T1-T4) - fell. The trees are planted too close together and are now competing for the light. They block all light to the garden. T2 and T3 are in decline due to lack of light, T1 and T4 are preventing underplanting. T3 is also rooted in a steep tiered bank with limited rooting space. Replant with 3 smaller canopied trees (eg amelanchier).
