e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Deodar Cedar T3 (20M high, 900mm dia.) - Large tree at frontage to property on raised bank at the top of entrance steps to property. Overhangs roof considerably and is very close to roof tiles and windows.

Raise the canopy of the tree above the roof and frontage to give a reasonable clearance of 2 metres plus. Requires removal of 5 lateral branches that hang down close to the roof of 75 -100mm diameter and around 4 metres long. Crown clean by removing dead wood and snags.

Reason: To prevent direct damage to the roof and infrastructure of the property
