T1: Mature Holly: Approximately 9.00m. Reduce crown height by approximately 1.50m. Reduce lateral and sub-lateral branches by approximately 1.00-1.50m to form a more compact crown structure and ensure a 2.00m clearance of the building.

T2: Himalayan Birch: Approximately 10.00m. Thin crown density throughout by 20%. Reduce extraneous branches back into main crown structure (not more than 1.00m reduction. Ensure a 2.00m clearance of the building.

T3: Norway Maple: Reduce back to previous and most recent reduction/pollard points. Remove epicormic growth from main stem. Ensure a 2.00m clearance of building.

Reasons: General maintenance to increase light levels.
