Thanks Kate. Sorry for the slow reply. I seem to have missed the ability to comment online. Could I please register my objection with yourself?

The main points would be 1. removal of trees and lack of replacements of similar size where there seems to be space to keep them within the scheme. 2. removal of a hedge from the street boundary from the initial application which is a key feature in the willett conservation area. Without one the property would be jarring in the rhythm of the street view with several hedges on harley road and elsworthy. I believe there was an enforcement order for 30 harley road for a hedge which has never been actioned so it would be good to have a hedge put back into the scheme for 28.
