# Caracinional outstanding affice of

## 1. Responsibility for compliance

Owners/occupiers have a legal responsibility to ensure that the terms of the fire certificate are complied with. (The allocation of responsibility shown on page 3 defines precisely who is responsible for the requirements of the Certificate.)

Owners or occupiers who come to premises after the date of issue of the certificate should note that under the Fire Precautions Act 1971 it is they, **NOT** previous owners or occupiers, who are responsible for compliance.

## 2. Keeping of the Certificate

Whilst it remains in force, this certificate, (or this copy if issued to an occupier of a multi occupancy building), must be kept in the premises to which it relates. On a change of ownership/occupier, the certificate should be passed to the new owner(s)/occupier and the Authority informed of the change. Standard form FS/A4/8, a copy of which is included with this certificate, can be used for this purpose.

## 3. Alterations to the premises

(see also information contained inside rear folder cover)

The Fire Authority must be given prior written notice if it is proposed:-

- to make material extension of or material structural alteration to the premises; or
- to make a material alteration in the internal arrangement of the premises or in the furniture or equipment with which the premises provided.
- iii) to begin to keep under, in or on the relevant building where your premises are situated explosive or highly flammable materials of a kind and in a quantity prescribed by the Secretary of State or, in the case of factory premises, to begin to store or use explosive or highly flammable materials or materially to increase the extent of such storage or use.
- iv) to alter any automatic firefighting system (ie., sprinklers, drencers, deluge installation), other than as an exchange item under routine maintenance, that has been provided in the building for;
  - (a) life safety system protecting the means of escape routes.
  - (b) forming part of a fire engineered solution.
  - (c) fire control purposes as part of a fire evacuation procedure (ie., shopping malls and phased evacuation in buildings in excess of 30m high).

#### NOTE:

'Material' is taken to mean any alteration which could render the means of escape and fire precautions inadequate in relation to the use of the premises for which the certificate is issued. The Fire Authority's fire safety officers will be pleased to advise you if you are in any doubt.

#### 4. Penalties

Failure to:-

- keep any of the matters specified in this certificate in accordance with the specification, or failure to observe any of the requirements in Part C;
- ii) keep this certificate or, where appropriate, this copy of it, in the premises;
- iii) give notice to the Fire Authority before carrying out proposed alterations to the premises (see Section 3 above).

are all offences under the Fire Precautions Act 1971, for which there are prescribed maximum penalties.

### 5. Rights to Appeal

The Fire Precautions Act 1971 provides a right of appeal to a magistrates' court against various decisions concerning a fire certificate, but you must make your appeal within 21 days from the date on which the decision is made known to you.


