STUDY SITE

The Study Site is described as "1 Museum Street & West Central Street, Holborn, London", and it is centred on National Grid Reference 530180, 181400.

THREAT POTENTIAL AND RECOMMENDATIONS

The potential for a UXO hazard to occur, and more specifically, the potential for unexploded WWI and WWII ordnance to exist at this site is assessed as being LIKELY (*Figure 2*).

In accordance with *CIRIA* C681 Chapter 5 on managing UXO risks, *6 Alpha* recommends that the next stage in the risk management framework is:

REPORT SUMMARY

During WWII, the Study Site was situated within *Holborn Metropolitan Borough*, which recorded 216 High Explosive (HE) bomb strikes per 100 hectares; a very high level of bombing.

Luftwaffe aerial reconnaissance photography associated with the Study Site identified a drainage system (on-site) and a command post (750m south-east) as a primary bombing target.

Air Raid Precaution (ARP) records identified one HE bomb strike on-site. Additionally, five HE's were identified within 60m; the closest being 15m south-east. Furthermore, a V1 rocket strike was identified 180m south-east and 44 Unexploded Bombs (UXBs) were recorded within 1,000m; the closest being 220m north of the Study Site boundary.

London County Council (LCC) bomb damage mapping recorded *"serious damage; but repairable at cost"* and *"damage beyond repair"* on-site. In addition, "serious damage; but repairable at cost" was identified 40m south-east and "clearance areas" 20m to the north and 30m to the north-east.

Given that both bombing and bomb damage were recorded on-site during WWII; it would suggest that further action is warranted to address the potential for UXO encounter.

USING THIS REPORT

This Preliminary Assessment is designed to inform environmental and construction professionals of the potential threat of military related explosives and/or ordnance on, or in, the vicinity of the Study Site.

This assessment is designed to be employed as a site-screening tool to meet with the requirement of Phase One of the *CIRIA UXO Risk Management Framework*; there are two broad prospective outcomes; either the threat level requires a detailed threat & risk assessment; or no further action is required. In the former instance we can provide a report within 10 working days (or more quickly upon application).

Two figures accompany the report, the *Second World War* (WWII) High Explosive (HE) Bomb Density and the final Probability of UXO Encounter. The purpose of this approach is to demonstrate that whilst bomb density statistics give an indication for WWII bombing, they should not be relied upon exclusively to generate a holistic assessment.

Should it be required, this would be addressed in the 'Detailed UXO Threat & Risk Assessment' (Stages 2 and 3).

WWII High Explosive Bomb Density








Probability of UXO Encounter






