Hi Debbie

Good to hear from you. Yes I was the lead officer for the original permission and continue to be involved as much as I can. I've attended a few Community Liaison meeting but not as many as I'd like.

With regards to the section 73/minor material amendment application you've referenced, you're spot on with your description. They are making minor changes to the detailed design of the consented development. These are mostly to the elevations of Plot 1, which is the large building within the courtyard (and replacing some of the demolished wings) of the former Royal Free Hospital.

I think the cover letter (attached) explains the changes clearly. To summarise the main changes are:

- Internal works such as a new layout to the lecture theatre on the ground floor
- Minor changes to the façade treatment, at the lower levels to the side and rear of the Plot 1 building
- Relocation of an escape door to the rear
- Updates to detailed design of elevation facing Calthorpe Community Gardens
- New plant (automatic opening vent) on the roof

The majority of the changes are relatively minor tweaks to the detailed design. The building is not getting any bigger nor is it significantly changing.
