Proposed Work:

FRONT GARDEN BOTH FRONTAGES: 3 x Limes (T1) - Reduce crown by 40%, 4m of height and 2m of width.

1 x False Acacia (T2) - Reduce crown by 40% 4m of height and 2m of width.

11 x Limes (T3, T4, T5, T9, T10 -T16) - Reduce crown by 35%, 3.5m of height and 2m of width.

1 x Purple Leaf Plum (T17) - Cut back from road by 2m.

1 x Purple Leaf Plum (T19) - Reduce crown by 25%, 0.5m of height and 1m of width.

1 x Lime (T20) - Reduce crown by 30%, 2.5m of height and 1.5m of width.

The Council has considered your notification of intended works to trees dated 13 May 2021 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS

3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works.
