## **DECISION**

Proposal:

Erection of single storey ground floor rear extension.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

- 1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

- 2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 of the London Borough of Camden Local Plan 2017.

- 3 The development hereby permitted shall be carried out in accordance with the following approved plans: ELL28-PL-GA-05, ELL28-PL-GA-03, ELL28-PL-GA-04, ELL28-PL-GA-02, ELL28-EX-GA-03, ELL28-PL-GA-01, ELL28-EX-GA-05, ELL28-EX-GA-02, ELL28-EX-GA-05, ELL28-EX-GA-02, ELL28-EX-GA-04, ELL28-PL-GA-01

Reason: For the avoidance of doubt and in the interest of proper planning.

Informative(s):

- 1 The overall size, height and depth of the proposed single storey rear extension is considered to represent a subordinate addition that would not have a significant impact on the original character and proportions of the host dwelling. The extension would be finished in brick to match the appearance of the existing building and is considered acceptable. Whilst the proposed extension would project beyond the side elevation of the host property, this projection is considered minimal (approx. 1.2m) and would not have significant impact on the appearance of the host property given its significant set back from the front elevation.

The proposed extension would have some visibility from the public realm along King Henry's Road. However, its modest size and simple design is not considered to cause harm to the character of the surrounding area, particular as it would largely match the size of neighbouring rear extensions in the terrace which share the same visibility.

The height and depth of the extension is not considered to cause harm to neighbouring amenity in terms of loss of light or outlook. The proposals would not increase the size of the first floor balcony at the site and the ground floor windows would share the same outlook as the existing windows, ensuring no loss of privacy would occur as a result.

No objections were received following statutory consultation. The site's planning history and relevant appeal decisions were taken into account when coming to this decision.

As such, the proposal is in general accordance with policies A1 and D1 of the Camden Local Plan 2017. The proposed development also accords with the policies of the London Plan 2021 and National Planning Policy Framework 2019.

- 2 Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts that cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. - 3 This approval does not authorise the use of the public highway. Any requirement to use the public highway, such as for hoardings, temporary road closures and suspension of parking bays, will be subject to approval of relevant licence from the Council's Streetworks Authorisations & Compliance Team, 5 Pancras Square c/o Town Hall, Judd Street London WC1H 9JE (Tel. No 020 7974 4444). Licences and authorisations need to be sought in advance of proposed works. Where development is subject to a Construction Management Plan (through a requirement in a S106 agreement), no licence or authorisation will be granted until the Construction Management Plan is approved by the Council.
- 4 All works should be conducted in accordance with the Camden Minimum Requirements - a copy is available on the Council's website (search for 'Camden Minimum Requirements' at [www.camden.gov.uk](http://www.camden.gov.uk)) or contact the Council's Noise and Licensing Enforcement Team, 5 Pancras Square c/o Town Hall, Judd Street London WC1H 9JE (Tel. No. 020 7974 4444)

Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. You must secure the approval of the Council's Noise and Licensing Enforcement Team prior to undertaking such activities outside these hours.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraph 38 of the National Planning Policy Framework 2019.
