T1 - copper beech tree (12m) - lift crown by up to 3m, reduce lower remaining branches over garden by up to 2m (with pole pruners from ground), reduce height by approximately 3m.

T2 - copper beech (12m) - lift crown by up to 2m, reduce height by approximately 3m.

T3 - elder tree (3m) - remove stem pushing on fence. T4 - Hazel tree (8m) - reduce height to 2m from ground level
