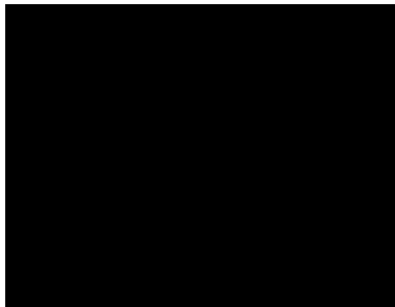
I hope you are well.

Internal plant

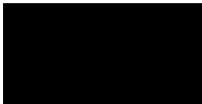
Cold room details attached.

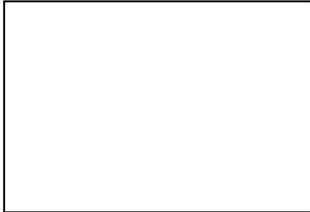

Thank you for submitting the above application on 11/05/2021. I will be your case officer. Before I validate the application I just wanted to check that you have filled in the correct ownership certificate on the application form. You have filled in Certificate A, which suggests that the applicant owns all of the land within the red line. However, I would have expected the applicant to need to serve notice on the owners of flats within the building. If this is the case, please could the applicant fill in the attached form and serve notice on the relevant people and please could you fill in Certificate B and send it to me.

As part of the assessment of the application I will also need details of the likely frequency of trips to and from the site and the likely mode of transport. The Transport Officer may request more details, I will let you know.

I also assume that some form of plant will be required in order to keep items being stored at the site cool? Can you confirm and provide details.

Could you also confirm where the bins are currently stored? And will there be any external changes to the host building?
