University College School 2021/3165/T: TPO request

The willow trees above the underground River Westbourne outside UCS school had long been an iconic part of the Frognal streetscape.

Unfortunately, consent was granted to fell nine of the ten willows in 2003, without any apparent reason (application TCX0306184). The last remaining willow, photographed below, is as important to the setting of the listed building as it is to the setting of the Redington Frognal Conservation Area.



Redington Frognal Neighbourhood Forum would therefore like to request that a TPO be issued for this last remaining willow on the grounds of its:

- Visibility. The extent to which the tree can be seen from a public place, such as a road or footpath, or accessible by the public.
- Contribution to, and relationship with, the landscape; and
- Contribution to the character or appearance of the Conservation Area

9 x Willow (salix) - fell/remove, and has no objections to the
proposed works.

Standard Informatives

2. Please note that all tree work should be carried out in
accordance with the relevant recommendations of BS 3998: 1989
(Recommendations for Tree Work).
3. It is the Contractor's responsibility to report any serious
defects noted whilst working in or climbing the tree(s). If
additional work is needed, the Council should be notified in
advance. This does not apply where safety reasons require
immediate and urgent attention.



4. If a tree is removed, uprooted or destroyed or dies at a time when work on the tree is authorised because it is dead, dying or dangerous or because it is causing a nuisance, the landowner is placed under a duty to plant another tree of an appropriate size and species at the same place as soon as is reasonable.



Please note that any approval given by the Council does **not** give exemption from the requirements to comply with The Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests, whilst being built or in use.
