e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1: Bay: Rear Garden: Reduce crown by approximately 30%. Reason: To shape and balance

T2: Norway Maple: Rear Garden: Fell as near as to ground level as practicable or cut to the height of seat level. Treat with systemic herbicide. Reason: Dead tree

T3 Norway Maple: Rear Garden: Reduce crown back to most recent reduction points. Thin remaining crown density by 20%. Reason: To preserve the trees natural characteristics and aesthetic value.

T4 Robinia: Neighbouring garden: Right hand boundary: Overhanging the garden room. Raise low branches by approximately 1.50-2.50m. Reason: To clear the overhang from the garden room. T5: Laurel: Front Boundary: Laurel: Reduce crown by approximately 20%. Reason: Remove dead wood, Reduce and shape.

Front Garden: Mixed species hedge line: On the boundary with No.4. Reason: Trim to tidy.
