### **GRANT CONSENT FOR WORKS TO TREE/S UNDER A TREE PRESERVATION ORDER**

Proposal:

FRONT GARDEN: 1 x Lime (Tillia sp.) - Reduce and Re-establish as a pollard by removing approx 5m - 6m from height (to match plane tree adjacent at number 20). Remove remaining growth back to previous points and remove epicormic growth from main stem and around base to form a more compact, manageable crown.

The Council has considered your application dated 10 June 2021 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.

- 2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)


Reason: To ensure the preservation of the amenity value and health of the tree(s).
