EW00 - End-weight reduction to specified extent, remove largest diameter section (approximately 22cm x 1m - one of three forks) at end of major NW lateral branch to relieve mechanical loading and manage risk of limb failure.

T114 & T122 - Ilex aquifolium (Holly):

LPD - Lift low canopy - Pedestrian clearance to 2.5 m over footpath.

T115 - Laurocerasus lusitanica (Portugal Laurel):

RL00 - Reduce faulted limb(s), between 1-4m off upright stems in contact with neighbouring tree to remove rubbing limbs and prevent further damage to either tree. Remove deadwood.

T95 - Platanus x hispanica (London Plane):

RVX - Remove specified limb(s), 15m SW over internal footpath, off large limb, branch approximately 4m x 9cm with epicormic growth on underside, suspected early stage massaria colonisation.
