Thank you for your email and for the work you and your department are doing to resolve this matter.

However the addition of a long window and the enlargement of existing windows to the rear of the building remain a cause of concern. I have tried to arrange a meeting with the occupant to amiably discuss these matters but my request has been ignored. As for another building overlooking gardens the owners of the flats of KCC have been issued very strict rules and regulations for the use of these areas. The occupant has assured us that she has no interest in overlooking other properties but a new owner might not be so incurious.

As for the front—this Terrace 1-8 Tobin Close used to be leasehold property. When we purchased the freehold under the Leasehold Reform Act our freehold was subject to covenant. This covenant, which has not lapsed so far as we know, stated that the existing garage doors and general appearance of the close remain uniform Surely the proposed windows, small as they are, over the garage door breaches this covenant and we feel you should investigate this.
