They property adjoins a large number of dwellings. Unfortunately we know from experience with the previous owner, that noise from Fitzroy Yard is very disruptive indeed for a large number of people. The proposal would tend to exacerbate the potential for noise generation.</p> <p>I am equally concerned about the level of light pollution which the proposal seems to entail.</p> <p>I wish to point out that I am an owner of an adjoining property, 12A Manley Street NW1 8LT. However, I have received no notification of this proposal. It was drawn to my attention by concerned neighbours in other adjoining properties in Manley Street, who likewise had not been officially notified.
