Starting from black gate on main road side starting from Avenue Close Block of flats (Black gates on road side) leading to main entrance to 1-33 Avenue Close

1 x Sycamore - Lift overhanging branches growing towards road side and public footpath up to 10ft clearance from starting from footpath.

1x Holm Oak - Lift overhanging branches growing towards road side and public footpath up to 10ft clearance from starting from footpath.

1x Holly - Lift overhanging branches growing towards road side and public footpath up to 10ft clearance from starting from footpath.

1x Privet - Lift overhanging branches growing towards road side and public footpath up to 10ft clearance from starting from footpath.

1x Lime - Lift overhanging branches growing towards road side and public footpath up to 10ft clearance from starting from footpath.

1x Yew - Lift overhanging branches growing towards road side and public footpath up to 10ft clearance from starting from footpath.

1x Purple Plumb - Lift overhanging branches growing towards road side and public footpath up to 10ft clearance from starting from footpath.

1x Yew - Lift overhanging branches growing towards road side and public footpath up to 10ft clearance from starting from footpath.

1x Apple - Lift overhanging branches growing towards road side and public footpath up to 10ft clearance from starting from footpath.

1x Sycamore - Lift overhanging branches growing towards road side and public footpath up to 10ft clearance from starting from footpath.

1x Lime - Lift overhanging branches growing towards road side and public footpath up to 10ft clearance from starting from footpath.

1x Lilac - Lift overhanging branches growing towards road side and public footpath up to 10ft clearance from starting from footpath.

The reason for works to be carried out is the mixed species trees/shrubs are growing to far over the public footpath and near the bush main road, they need to be managed and cut back for safety reasons and sight lines for passing HUV's, cars etc.

Located in rear garden adjacent to property -

(T1) Tree of Heaven - Cut back branches encroaching towards adjacent property leaving a 1m gap between tree and property to avoid debris from dropping into guttering and to avoid squirrels from dropping onto the roof tops.

(T2) Tree of Heaven - Cut back branches encroaching towards adjacent property leaving a 1m gap between tree and property to avoid debris from dropping into guttering and avoid squirrels from jumping onto the roof tops.
