T1: Bay: Rear garden: Left hand Boundary: Too large for it's location. Reduce the crown all round by 30-40%. Reducing overhang back from No.4 as near to the boundary.

T2: Elder: Rear Garden: Right hand boundary: To prevent encroachment. General maintenance. Reduce crown by 20%. Thin crown by 20%.
