I am Keith Fawkes and have owned my eponymous local rare book and antique shop at [1-3 Flask Walk](#) for in excess of 50 years. My antique shop, where I work every day, is Grade 2 listed and due to the nature of my work and my expertise in historic artefacts, I know and have visited almost all of the listed buildings in Hampstead.

Of all the historic houses I have seen in the local area, [111 Frognal](#) was in particularly bad repair and was very poorly converted in the 1960s with very little historic fabric left. Renovation works and structural repairs were necessary and inevitable.

I am thus writing to support the repairs, renovations and modest extension works Zoe and Merlin propose to [111 Frognal](#). The repairs to the cellars were necessary for the structural stability of the house and the changes that Merlin and Zoe are proposing are both modest and discreet and in keeping with the listed building and will be an asset to the conservation area in safeguarding this listed asset for generations to come.
