Tree 39 - Establishing Tulip tree within courtyard area with developing low crown hindering path users:

- Carry out sensitive crown lift to approx. 3.5m to an even level by the reduction of low hanging branches, all cuts to be made to suitable secondary growth points

Tree 49 - Variegated Norway maple on edge of South Lawn near parking bays:

- Carefully prune out reverting sections to improve overall appearance

Tree 51 - Over mature Common laburnum within herb garden planted beds with evidence of some decline in condition:

- Carefully remove major deadwood
- Reduce height of limb adjacent to path with decayed section by approx. 1.5m to alleviate weight

Tree 52 - Establishing Magnolia on edge of South Lawn near parking bays:

- Reduce longer protruding sections (approx. 1.5m reduction) back into overall profile of canopy to form a more compact and balanced framework
- Carry out sensitive crown lift to approx. 1.5m to an even level, all cuts to be made to suitable secondary growth points

Tree TG60 - Multi stemmed mature Gleditsia in SW corner of South Lawn:

- Carry out sensitive crown lift to approx. 5.5m to an even level, all cuts to be made to suitable secondary growth points
- Remove major deadwood
