Sycamore x 4 G1 (18M high, 350/450mm dia.) - Reduce heights of crowns back to most recent points of reduction (4 metres)

Pine x 4 G2 (10M high, 150mm dia.) - Reduce height by 2.5 metres and laterals by up to 1.5 metres.

Silver Birch x 2 G3 (16M high, 350mm dia.) - Raise canopy to clear roof by 2 metres
