Oak (T1) - (selectively) reduce crown by up to 2m, by removal of overlong branches, to create a flowing canopy shape, crown lift to 5m from ground level. This work is proposed within the realm of good arboricultural practise and is to maintain the tree in a size that is proportional to its location between the public highway and the house.
