The entrance to the Cascades basement is barely three car lengths from the traffic lights at the junction of Finchley Road and Hendon Way. There is already enormous congestion at this point. Because of the way that traffic flows from Hendon Way, at busy times, no more than one or two vehicles from the Finchley Road direction can cross the traffic lights at any one light change. Traffic already backs up on the Finchley Road back towards Cricklewood Lane. Under the proposed development, there would be a constant stream of vehicles into and out of the basement, and no doubt some delivery lorries would park on the road outside the basement. All this extra traffic would just exacerbate the congestion problems leading up to the traffic lights. Congestion would be further increased by the fact that delivery lorries could only reach the basement via Lyndale Avenue or Briardale Gardens (two residential roads) or via Finchley Road itself. (ii) Danger to pedestrians. The pavement between Briardale Gardens and Hendon Way is extremely busy with pedestrians, many of them children. The flow is increased by the fact that there is a busy bus stop just a few yards from the basement entrance. Vehicles constantly crossing the pavement into and out of the basement would cause great danger to the pedestrians walking past this point. (iii) Pollution. The air pollution rates in this area are already 50% above the legal limits. The proposed basement development will increase the volume of traffic and thus the pollution levels in the area. Such levels are particularly dangerous for children and the vulnerable. (iv) Effect on Barnet residents. It should be noted that the Cascades Apartments are on the edge of Camden. The only nearby Camden residential property is in Briardale Gardens. However, immediately opposite the Cascades are two blocks of apartments that lie within Barnet – Wendover Court and Morela
