TREES ARE ALL IN HILLFIELD COURT, BELSIZE AVENUE (I had to select 23 as there was no other option).

T14 Silver Birch (x1) - Fell to ground level. Reason: Poor specimen.

T15,16&18 Silver Birch (x3) - Reduce heights by 2.5m and widths by 1-1.5m. Reason: General maintenance. To maintain the trees at a smaller size.

T21&22 Silver Birch (x2) - Reduce side facing building by 1.5m and crown lift to 4m. Reason: General maintenance. To maintain the trees at a smaller size.

T27 Bay Tree (x1) - Reduce height by 1.5-2m. Reason: General maintenance. To maintain the tree at a smaller size.

T44 Oak (x1) - Tree is dead.

T58 Sycamore (x1) - Reduce height by 3.5m and width by 2.5m all around and thin crown by 20%. Reason: General maintenance. To maintain the tree at a smaller size.

T59 Sycamore (x1) - Reduce crown back to previous points of reduction (8m off height and 3m off width). Reason: General maintenance. To maintain the tree at a smaller size.

T61 Pear (x1) - Fell to ground level. Reason: Poor vigour, tree in terminal decline.
