Reduce crown by - Specified extent. to previous reduction points (approx. 2-4 m), ensuring a balanced crown, to alleviate mechanical loading and minimise risk of limb failure.

T199 Aesculus hippocastanum (Horse Chestnut):

Reduce crown by - Specified extent. to previous reduction points (approx. 2-5 m), ensuring a balanced form, to minimise wind loading due to restricted rooting environment and to manage conflict of overhanging crown close to building.

T200 Cerasus serrulata (Japanese Cherry):

Prune from adjacent structure. - reduce lateral branch near building by 2 m.
