e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

(T1) - Ash (Fraxinus excelsior)
-reduce to match the height of previous pruned ash RETAINING 4m above ground level
-reduce side branches to match, shape, balance, and tidy

(T2) - Plum (Prunus)
-reduce entire crown by 25% to suitable growth points
-reduce lateral branches to match
-thin by 15% to allow more air/light through canopy

(T3) - Monterey Cypress (Cupressus macrocarpa) - dead and covered in creeper growth
-fell to ground level

(T4) - Holm Oak (Quercus ilex)
-reduce crown height to match neighbouring tree retain 3m above ground level
-light trim all sides to shape and tidy

All works other than fell for routine maintenance. Felling T3 - dead and overtaken by creeper
