e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

(T1) Horse Chestnut - The limited rooting potential coupled with the fact that the canopy of T1 has been opened to prevailing winds through the loss of a tree on site create structural stresses that require mitigation. I would advise further reduction works. In this instance I believe that this tree should be reduced below the adjacent canopy of PT6 and PG4 approximately 3m in height reduction and balancing the width accordingly, this would be below current reduction point by approximately 1m and represent an overall crown volume reduction of 40%. This works will mitigate the potential for windsail and minimize pressure on the extremely limited rooting structure.
