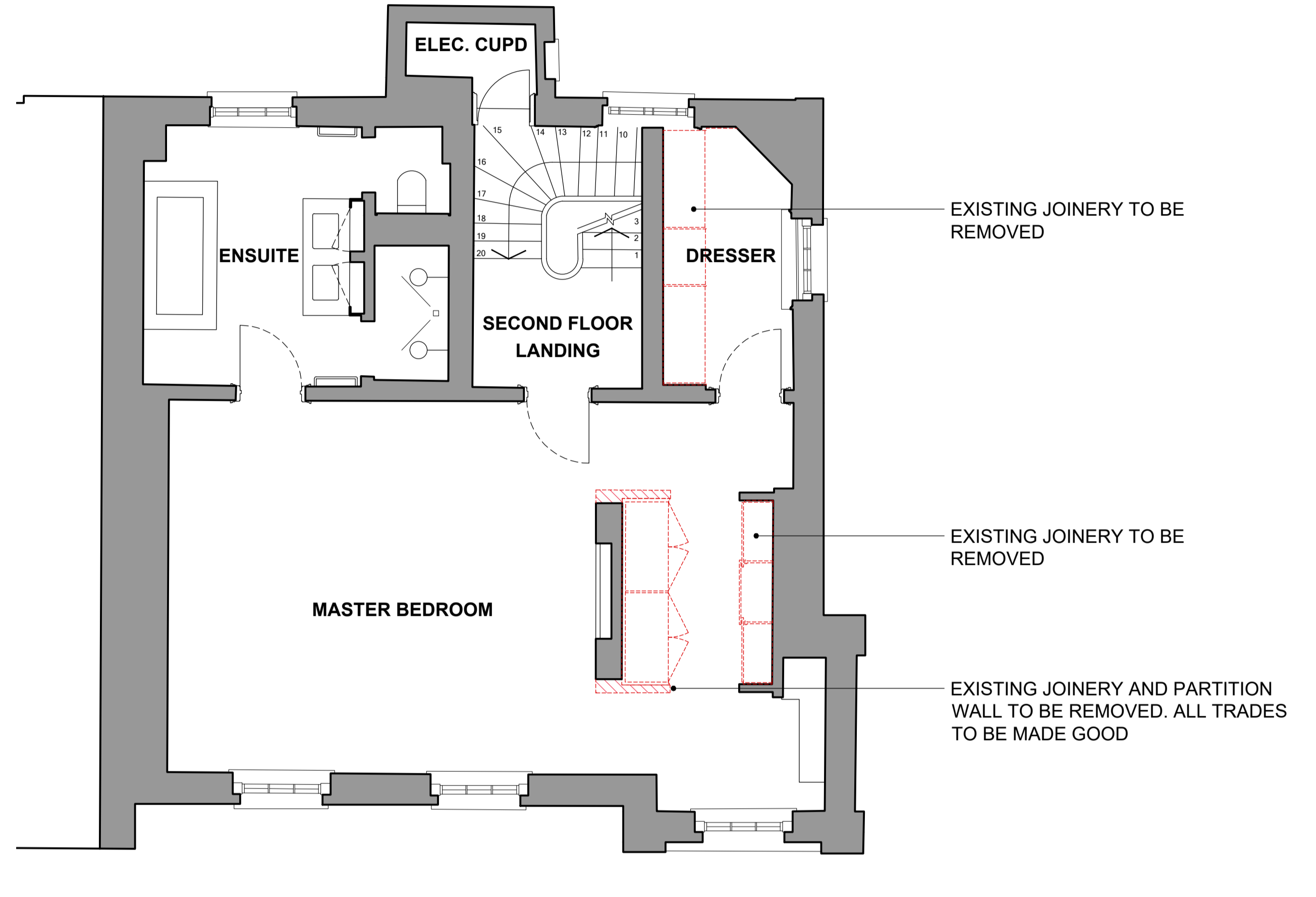


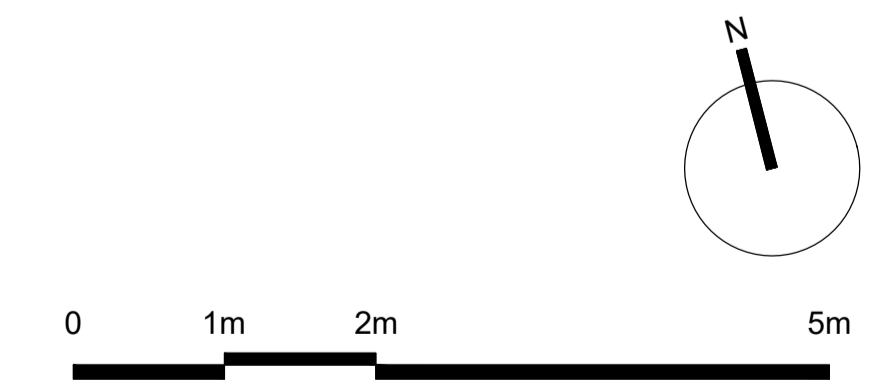
01 FIRST FLOOR PLAN
