e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1: Pittosporum - (overhanging from Follie House on East Heath Road): Reduce overhang back by approximately 1.50m.
Reason: General maintenance to control encroachment.

Rear Garden:

T2: Magnolia: Thin crown density by 15-20%. Reduce any over long extraneous branches back into main crown structure by no more than 20%.

T3: Acer - (lefthand boundary): Reduce crown by approximately 20-25%.

T4: Birch - (nearest the house): Thin crown density by 20%. Reduce crown by approximately 20% (1.00m).

T5: Birch - (rear boundary): The crown of this tree is now joining the crown of T3. Thin crown density by 20%. Reduce section of crown overhanging neighbouring property by 0.50m. Reduce lateral and sub lateral growth back by approximately 1.00m on house side to separate crown from T3.

T6: Smaller Bay - (rear boundary): Reduce crown by approximately 30% (1.20-1.50m).

T7: Large Multi-stemmed Bay: Reduce height back to previous reduction points. Reduce lateral and sub lateral crown spread as hard back as is practicable whilst preserving fine branch structure (10-25cm).

G1: Row of mature Magnolia Grandiflora: Reduce extraneous growth back over lawn by 0.50m. Reduce back from neighbours to the rear by 0.50m. Tip prune height by up to 1.00m to promote density of screen in lower areas of the trees.

G2: Bamboo & Photinia (Red Robin) Group: Reduce or remove wayward and damaged Bamboo stems. Reduce Photinia by approximately 1.50m.

S1: Trachelospermum: Trim face to tidy. Raise lower section. Trim higher section to control encroachment.

S2: Griselinia: Reduce by approximately 1.50m.

Reason/s: General maintenance and to control encroachment.
