T4Indian Bean Tree x (Catalpa bignonioides) This tree has also been forced and approximately 80-90% of its crown is overhanging the neighbouring garden - Reduce in height by 2-2.5m - reduce the overhang by 1-1.5m - Remove the x2 lowest branches that run along the fence line - selectively thin remaining crown by 10-15% - Raise the crown on the neighbours side by up to 50cm
