T4 - Chestnut Tree - Reduce all round by 4m.
T6 - Pyracantha - Remove to ground level. Due to low amenity value and excessive shading within the garden.

Reasons for proposed works: Tree works proposed are required in order to increase light levels within the garden whilst maintaining good arborucultural practice and ensuring all aspects of health and safety have been reduced with the works proposed.
