GRANT CONSENT FOR WORKS TO TREE/S UNDER A TREE PRESERVATION ORDER

Proposal:
ON VERGES: 1 x Ash (T1) - Fell to ground level.
1 x Field Maple (T4) - Prune to clear the building by max. 2m.
1 x Cherry (T6) - Fell to ground level.

The Council has considered your application dated 04 April 2021 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.

- 2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the

tree(s).

- 3 Within the first available planting season (2021-2022) following the completion of works, 1 x wild cherry (*Prunus avium*) and 1 x field maple (*Acer campestre*) shall be planted as a standard with a girth size of 16-18cm, within 5m of the removed tree unless otherwise agreed in writing by the local authority. Evidence of this shall be submitted to the council. The planting process should take into account the standards set out in BS8545:2014. Any trees removed, dying, being severely damaged or becoming seriously diseased within 5 years of planting shall be replaced by trees of a similar size and species to those originally required to be planted.

Reason: In order to comply with the provisions of Section 206 of the Town and Country Planning Act 1990 (as amended).

Informative(s):

- 1 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
