Proposed Work:

REAR GARDEN: 1 x American Horse Chestnut (T1) - Thin crown density by 15% -20%. Reduce lateral and sub-lateral branches growing towards and over garden by approx. 1m. Reduce remaining extraneous branches back into main crown structure (not more than 20% crown reduction). Raise crown by 1.5m - 2m.

1 x Lime (T2) - Thin crown density throughout by 20 % -25%. Reduce crown height by up to 2m. Reduce lateral and sub-lateral branches by approx. 2.5m. Remove lowest branch overhanging No.146.

1 x American Horse Chestnut (T3) - Thin crown density by 15% - 20%. Reduce lateral and sub-lateral branches growing towards and over garden by approx. 1m. Reduce remaining extraneous branches back into main crown structure (not more than 20% crown reduction). Raise crown by 1.5m - 2m.

The Council has considered your notification of intended works to trees dated 29 April 2021 and does not wish to object.

- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works.
