GRANT CONSENT FOR WORKS TO TREE/S UNDER A TREE PRESERVATION ORDER

#### Proposal:

FRONT GARDEN: 1 x Lime (Tilia) (T2) - Crown reduce the height and spread by 33%.

- 1 x Sycamore (Acer pseudoplatanus) (T4) Remove one low branch over road.
- 1 x Sycamore (Acer pseudoplatanus) (T5) Remove one low branch over road, reduce the second branch over the road by 3m 3.5m.
- 1 x Lime (Tilia) (T7) Reduce the low branches over the road by 2m 2.5m.
- 2 x Yews (Taxus baccata) (T8 & T9) Reduce unruly branches over the pavement to shape.
- 1 x Lime (Tilia) (T10) Reduce the height by 6-7m, reduce the remaining spread to shape.
- 1 x Lime (Tilia) (T18) Remove low branches over the pavement and road to give a clearance of 3m and 6m respectively.
- 1 x Yew (Taxus baccata) (T19) Remove the low branches over hanging the pavement to give a clearance of 3m.
- 3 x Limes (Tilia) (T23, T24, T25) Remove low branches over hanging the pavement and road to give clearance of 3m and 6m respectively.
- 3 x Cherries (Prunus) (T26, T27 & T28) Fell to ground and grind stump out.
- 9 x Limes (Tilia) (T29 T37) Remove the low branches over hanging the pavement and road to give a clearance of 3m and 6m respectively and reduce the branches overhanging the bungalow by 3m 3.5m.
- 1 x Cherry (Prunus) (T38) Fell to ground and grind stump out.
