Thank you for inviting Vector Structures to submit a proposal for the provision of Structural Engineering Design services in connection with the above.

We have proposed a fixed price baseline fee based on the services set out in your enquiry and our recent discussions.

VECTOR STRUCTURES PRIMARY SCOPE OF SERVICE:

Our proposed scope of works are generally those described in the tender documents subject to the clarifications noted within this proposal.

The size and complexity of the structures being essentially:

- Erection of a new storey above existing WC on rear of the building
- New Rear extension on area known as "rear area" with the capability to hold 1No. storey above.

In order to satisfy part A of the building regs, our fee will include the following components;

Design of Super Structure

- Design of Steel Beams
- Design of Beam Bearings
- Generic Steel connection details
- Masonry Check
- Design of Floor Joists
- Specification of Lintels

Design of Sub Structure

- Desktop Study
- Foundation Advice

Drafting

- Production of Beam & Column Schedules
- · Structural layout Plans
- Connection Detailing

Please note the following clarifications and assumptions relating to the proposal:

- We have included the design of foundation widths assuming they are on competent strata.
 The fee proposal does not include a specialised foundation design such as piles, ground beams or foundation depths due to proximity to the trees. Furthermore, it does not allow for underpinning drawings or specification.
- Planning and Building Regulations submissions and associated fees will be the responsibility
 of the Architect and/or Client.
- In the event of any significant changes to the architectural layout, we reserve the right to charge additional fees.
- We have not included for any costs associated with any ground investigation surveys.
- We have not included for any costs associated with the staircase and balustrade design as these items will be as per manufacturer/specialist specifications.
- We have not included for the design of any external works, including below-ground drainage design, or any Temporary Works.
- We have not included for any costs associated with material testing.
- Due to COVID19 we have not allowed for any site visits hence we will be liaising with the client to obtain the information required.
- Information from the desktop study has suggested London Clay to be present hence a suspended slab solution will be presented.
- In accordance with the planning permission conditions, our consultant Chris Boydell CEng, BSc, FICE, MIStructE will be reviewing the design and all drawings that we are preparing and will make site visits or monitor construction progress via video link subject to covid restrictions.
